That the social and cultural dimensions that are based on the point of Saudi women working in strengthening the integrity of view and the fight against corruption was that of the most important reasons that lead to change the ethics of people from the point of the Saudi working women consider are the weakness of the religious faith and the disintegration and weaknesses of family relations, satellite TV and the Internet. The obstacles facing Saudi women working for the performance associated with the social role of the family in promoting integrity and combating corruption. Were as follows:

of administrative cadres and successful leadership able to promote integrity in social institutions, with inadequate material and moral incentives systems, leading to rampant corruption in the social institutions.

ignorance of some parties to the principles of education from the viewpoint of Islam and the weakness of social culture that affect the role of women in socialization and the inability of the family for emptying the prevailing cultural waves in all directions and the restoration of the educational role.

lack of awareness of the rules and lack of commitment by some laws in social institutions with a lack of material and human resources to raise awareness of corruption and various image in some social institutions with no accountability or accountability or performance evaluation in social institutions.

the impact of foreign culture in the culture of the Islamic peoples, particularly with regard to morality and the difficulty of removing the effects of penetrating cultures in the community and the individual immunized continuously with respect to any deviation from the performance of his duties and the presence of some media programs with negative implications.

lack of awareness of the importance of women's role in contributing actors in the fight against corruption and involvement in work outside the family and shrinking the actual role.

The obstacles facing Saudi women working for the performance associated with its role in the social work in promoting integrity and combating corruption. Were as follows:

The poor performance of the production of regulatory bodies and institutions in the work of the state and the presence of senior staff immunity that protects them from accountability, leading to widespread corruption.

Lack of awareness and ignorance of the concept of corruption by employees in spite of the presence and absence of awareness of the rules and lack of commitment by some laws and lack of courage among the employees for reporting Almstbhatt and fear of senior leadership, and the lack of material and human resources to raise awareness of the phenomenon of corruption and different image.

not to develop regulatory administrative and financial systems to ensure clarity and effectiveness of an acute shortage of qualified technical personnel of national supervisory and professionally qualified for the detection of corruption with no administrative cadres and successful leadership able to promote integrity.

weakness functional sense of responsibility towards the development and progress of society and the weakness of awareness among employees of the importance of transparency and accountability in the reduction of corruption and lack of awareness of the rules and the lack of people's commitment to each of the laws and dependency and inability to express an opinion and cover up the others.

weakness media efforts to raise awareness of the dangers of corruption with weak social culture phenomenon of corruption, leading to the spread of conflict of laws and strict penalties for anti-corruption and uneven application.

Not eating academics of the phenomenon of corruption when conducting scientific research or graduation projects. Students and (lack of transparency and freedom of information).

there are different forms of corruption by the executive authorities in the scope of work and to maintain personal relationships in the workplace, which helps to rampant corruption. Enjoy the freedom and wide the officials to act without accountability and the lack of accountability or accountability or assessment of the performance of civil and governmental institutions.

- special regulations, laws and legislation Knowledge, included the following in order of importance: (knowledge of the rules of professional and institutional settings. Knowledge of working in government institutions and civil laws. Study the Penal Code to combat corruption).
- educational knowledge, include the following in the order and importance: (familiarity means proper socialization within the family. Access to modern educational programs. Ensuring that women are a good example and a model morally inside and outside the family. Confirm women to entrench the principle of justice and the preservation of the rights of others).
- Knowledge and general information, include the following in order of importance: (knowledge of anti-corruption laws. Work to increase awareness of the dangers of corruption. Respect and protect the rights of others. Proposal strict laws to combat corruption. The development and evaluation of systems on the face of corruption).
  - Emotional aspects that you need Saudi women working to promote integrity and combat corruption, including the following in order of importance:
- relations and communication skills: communication and intellectual acceptance. Estimate the feelings of others. Sadr carrying capacity and other pressures. Control emotions. Cooperation and participation in the collective business.
- skills assessment feelings: self-esteem and understanding the feelings of others. Respect and appreciation for the feelings of Alakharan.altokid on positive emotions and avoid negative emotions.
- interaction skills with others: the ability to understand others. Ability to communicate clearly. Fitness in asking questions
- critical thinking skills: the ability to arrange ideas, analysis and arrange them clearly. Monetary through a specific scientific approach. Work group discussions. Attention skillfully Alkies- calendar, Altakiam- deduction.
- Behavioral aspects that you need Saudi women working to promote integrity and anti-corruption (life skills), included the following in order of importance:
